

THE CORPORATION OF THE CITY OF PEMBROKE

BY-LAW 2012 – 37

A BY-LAW TO AMEND BY-LAW 2005-55,
AS AMENDED, BEING A BY-LAW TO REGULATE AND CONTROL
THE PARKING OF VEHICLES IN THE CITY OF PEMBROKE

WHEREAS Section 11(1) of the Municipal Act, 2001, S.O. 2001, c. 25 states that a single-tier municipality may pass by-laws respecting highways, including parking and traffic on highways;

AND WHEREAS the Council of the Corporation of the City of Pembroke deems it expedient to amend By-law 2005-55, being a by-law to regulate and control the parking of vehicles;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF PEMBROKE ENACTS AS FOLLOWS:

1. THAT Schedule "L" – REGULATIONS FOR ISSUANCE OF PARKING PERMITS FOR THE USE OF PATTERSON PARKING LOT, CITY HALL PARKING LOT, PEMBROKE COURTHOUSE PARKING LOT AND BARRYMORE PARKING LOT (Part V, Section 2 (c), (d), (e) and (g) of By-law 2005-55 be amended by deleting therefrom the following:

SECTION 1 – PARKING PERMITS – CITY HALL

1. Parking permits shall be issued at City Hall, as follows:
 - (a) shall be issued for each month of the year;

SECTION 2 – PARKING PERMITS – PATTERSON, CITY HALL, PEMBROKE COURTHOUSE & BARRYMORE

1. The provisions of this by-law shall apply to vehicles parked or standing upon the Patterson Parking Lot, City Hall Parking Lot & the Barrymore Parking Lot
 - (a) 9:00 a.m. to 5:00 p.m.
 - Monday, Tuesday, Wednesday, Thursday, Friday and Saturday
 - (b) Monthly Permit - \$ 30.00 + G.S.T & P.S.T.
Six-Month Permit - \$150.00 + G.S.T. & P.S.T.
One Year Permit - \$250.00 + G.S.T. & P.S.T.
2. The provisions of this by-law shall apply to vehicles parked or standing upon the Pembroke Courthouse Parking Lot
 - (a) 7:00 a.m. to 10:00 p.m.
 - Monday, Tuesday, Wednesday, Thursday, Friday and Saturday
 - (b) Monthly Permit - \$ 30.00 + G.S.T. & P.S.T.
Six-Month Permit - \$150.00 + G.S.T. & P.S.T.
One Year Permit - \$250.00 + G.S.T. & P.S.T.
2. THAT Schedule "L" – REGULATIONS FOR ISSUANCE OF PARKING PERMITS of By-law 2005-55 be amended by adding thereto the following:

SECTION 1 – PARKING PERMITS – CITY HALL

1. Parking permits shall be issued at City Hall, as follows:

- (a) shall be issued for each month of the year or on an annual or semiannual basis;

SECTION 2 – PARKING PERMITS – PATTERSON, CITY HALL, PEMBROKE COURTHOUSE, MARKET SQUARE, ALEXANDER & BARRYMORE

1. The provisions of this by-law shall apply to vehicles parked or standing upon the Patterson Parking Lot, City Hall Parking Lot, Alexander Street Parking Lot, Market Square Parking Lot & the Barrymore Parking Lot

- (a) 24 hours, 7 Days a week
- (b) Monthly Permit - \$ 40.00 + H.S.T.
Six-Month Permit - \$200.00 + H.S.T.
One Year Permit - \$350.00 + H.S.T.

2. The provisions of this by-law shall apply to vehicles parked or standing upon the Pembroke Courthouse Parking Lot

- (a) 7:00 a.m. to 10:00 p.m.
- Monday, Tuesday, Wednesday, Thursday, Friday and Saturday
- (b) Monthly Permit - \$ 40.00 + H.S.T.
Six-Month Permit - \$200.00 + H.S.T.
One Year Permit - \$350.00 + H.S.T.

3. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by deleting therefrom the following:

2 (a)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, in the Alexander Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

4. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2 (a)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, or a vehicle with a valid parking permit, in the Alexander Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

5. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by deleting therefrom the following:

2 (b)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, in the Market Square Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

6. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2 (b)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, or a vehicle with a valid parking permit, in the Market Square Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

7. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2 (c)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, or a vehicle with a valid parking permit, in the Patterson Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

8. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2 (d)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, or a vehicle with a valid parking permit, in the Barrymore Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

9. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2 (e)(iv) No person shall park a vehicle, other than a vehicle used for emergency purposes, or a vehicle with a valid parking permit, in the City Hall Parking Lot between the hours of 12:00 midnight and 7:00 a.m. and any vehicle that is so parked may be removed at the owner's expense when such removal is authorized by a Municipal By-law Enforcement Officer.

10. THAT Part V – PARKING LOTS – Section 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2 (a)(vi) Parking permits for the Alexander Parking Lot shall be in accordance with the fees prescribed in Schedule “L” of this by-law.

11. THAT PART V – PARKING LOTS – SECTION 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2(b)(vi) Parking permits for the Market Square Parking Lot shall be in accordance with the fees prescribed in Schedule “L” of this by-law.

12. THAT PART V – PARKING LOTS – SECTION 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by deleting therefrom the following:

2(a)(i) The section of land lying south of Lake Street, west of Alexander Street and east of Agnes Street shall be established and laid out as a public parking lot.

13. THAT PART V – PARKING LOTS – SECTION 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2(a)(i) The section of land lying south of Lake Street, west of Alexander Street and east of Agnes Street shall be established and laid out as a public and permit parking lot.

14. THAT PART V – PARKING LOTS – SECTION 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by deleting therefrom the following:

2(b)(i) The section of land lying south of Lake Street, west of Victoria Street and east of Albert Street shall be established and laid out as a public parking lot.

15. THAT PART V – PARKING LOTS – SECTION 2 – PARKING LOT DESIGNATION AND TIME LIMITS – of Parking By-law 2005-55 be amended by adding thereto the following:

2(b)(i) The section of land lying south of Lake Street, west of Victoria Street and east of Albert Street shall be established and laid out as a public and permit parking lot.


16. Every person who contravenes any section of this by-law is guilty of an offence and on conviction is liable to a fine as provided for in the Provincial Offences Act, as amended.


