

By-Law Number 2018-60

**A By-law to appoint Council Representatives to Local Committees and Boards
for the Corporation of the City of Pembroke**

Whereas Section 10(2) of the municipal Act, 2001, S.O. 2001, as amended, from time, to time, indicates that a single-tier municipality may pass by-laws respecting the governance structure of the municipality and its local boards;

And Whereas the Council of the Corporation of the City of Pembroke deems it expedient to appoint Council representatives to the Corporation of the City of Pembroke local Committees and Boards;

Now Therefore the Municipal Council of the Corporation of the City of Pembroke enacts as follows:

1. That the following Council Member appointments to local Boards and Committees shall be confirmed as listed in "Schedule A" as attached to this By-law.
2. This by-law shall come into force and take effect upon the date of the final passing thereof.
